Contact Your Legislators

Your senator and delegates represent you in the Maryland General Assembly, which is now in session until April 9, 2018. They want to hear from their constituents so it is imperative that you keep up-to-date on legislation that just might affect you and especially your pension and health care.

MRSPA's Legislative Committee monitors all legislation that pertains to retirees: Long-Term Care Insurance, Property Tax Credit, Income Tax – Subtraction Modification – Retirement Income, Health Care Facilities – Nursing Homes, Income Tax – Credit for Long-Term Care Premiums, and the State Retirement and Pension System – State Employees and Techers – Benefits.

Visit MRSPA's website www.mrspa.org and click on the legislative tab for the latest information on bills. Then call, write, or email your senator or delegates to give them your opinion.

MRSPA's Legislative Committee will suggest whether to **support or oppose** proposed laws in the General Assembly's Senate and House of Delegates.

Or you can contact members of our Legislative Committee if you have any questions or thoughts on issues impacting retired educators and personnel.

Happy New Year! As 2017 closes and 2018 arrives, we reflect on the year that has passed. MRSPA had some wonderful accomplishments in 2017: Successful workshops, successful committees, and successfully protecting your pension. But reflection on our membership

reflection on our membership numbers, on our "Membership Matters" initiative, raises some concerns.

Membership Matters...Especially Yours and Each One Reach One have been my mantras for the last 18 months. I fervently believe that each member is important to the organization, and I know that we work hard every day to protect the pension and health benefits that you worked hard to earn. But the truth is that MRSPA is losing members. We have studied the problem and know that we need your help to turn this around.

The MRSPA Membership Committee has worked diligently to support the recruitment and retention work of the locals.

Just last year, at the request of the locals, they researched and wrote a white paper which explained why a retiree should join MRSPA. They have updated all our recruitment materials and created a survey of former members to understand why they dropped their membership.

Sadly, very few former members opted to complete the survey. All the good work of the committee and the local associations to recruit new members is offset by the loss of members.

Some of the loss (about 400) is because of the inevitableness of death. There is not much we can do about those losses, but continue to work to ensure their quality of life and proper access to *Continued on Page 3*

health care. But we are losing other cash dues paying members (more than 400) who simply did not send in their dues, when they were asked three times to make the payment.

This is more than a \$20,000 hit to an already small budget. Not to mention the \$3,000 it cost the organization to send those three notices.

MRSPA cannot sustain its existence for very long with these losses. That amount of money is more than our part- time staff is paid for an entire year.

We also cannot afford to lose our parttime staff and still maintain the level of service our members have come to expect from MRSPA.

It would be tremendously helpful and save money and trees, if all our cash paying members responded in a more timely fashion.

As I have said in every local in the state, Membership Matters in participation at the local level, in contributions to support the local and their projects and programs, and at the state level with advocacy and committee work.

When we lose members, we lose their valuable contributions and their voice in Annapolis. We cannot be successful in our mission without a strong, active membership.

Our strength is in our numbers. Will each one of you, reach out to a nonmember and ask them to join MRSPA today? If you believe like I do that *Membership Matters...Especially Yours*, I know you will.

If it's February, the Maryland Legislature must be in session! With 2018 being an election year, many believed that it might be a quiet session, with legislators not wanting to create any waves before Election Day. The opposite appears to be true for 2018.

The General Assembly's first action was to override the Governor's veto of paid sick leave for employees in companies with 15 or more employees.

The Governor is talking about legislation to set term limits for legislators, and there is already a bill to add a 401K-type plan to the pension system. This is Senate Bill 31 put in by Senator Bates of Carroll and Howard counties. The MRSPA Legislative Committee **opposed** this legislation with a letter and testimony to the Senate Budget and Tax Committee.

There are also bills related to studying nursing home quality, income tax relief for retirement income, and an annual long-term care insurance deduction, that we are following.

Dr. Vera Torrence was MRSPA's Legislative Aide in 2017. She had begun her work for 2018, but has been sidelined with an injury that caused her to resign her position. MRSPA's new Legislative Aide is Ms. Virginia Crespo, formerly the Legislative Committee Chair. Ms. Tish Raff has graciously accepted the position of Legislative Committee Chair for the 2018 session.

MRSPA thanks Dr. Torrence for her service and dedication to MRSPA and our members. We also thank Virginia and Tish for stepping up to accept new responsibilities on behalf of our members. They quickly moved into their new roles which created a seamless transition for the organization.

In this issue of the newsletter, you see a serious message from our president about membership. Do you have retired educator friends who are not members of MRSPA? We know that personal contact is the best way to recruit a new member, so don't be shy and ask them to become a member!

Scholarship Applications **Due by February 28**

Current school employees seeking teacher certification or a new certification in another education field may apply for one of three \$2.000 MRSPA scholarships.

Scholarship applications may be submitted from January 1 to February 28, 2018, online by setting up an online account and by securing a copy (official or unofficial) of your college transcript.

The name of the institution must be clearly visible and a minimum 2.5 GPA at the time of the application is required.

Uncertified teachers, paraprofessionals and other current public school system employees pursuing Maryland teacher certification may apply for one of the three \$2000 scholarships.

In addition, certified Maryland teachers pursuing Maryland certification in a different education specialty field such as school counselor, speech pathologist, school social worker, school psychologist and physical or occupational therapist are eligible.

Three \$2,000 scholarships will be awarded at MRSPA's Annual Business Meeting on May 8.


